

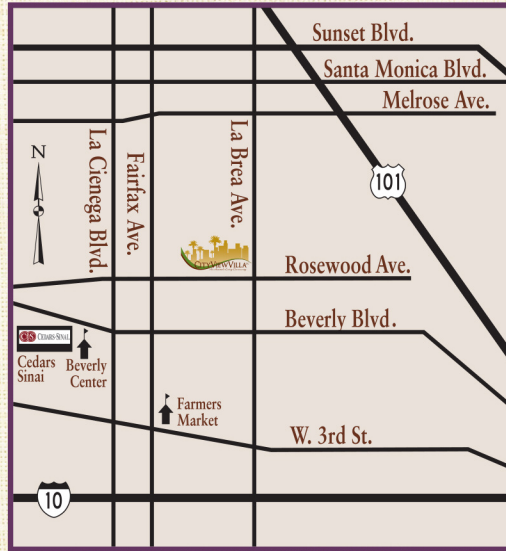
# ENGAGEMENT
